## SECTION 4. FIRST-AID MEASURES

- In case of skin contact : When using high pressure equipment, injection of product under the skin can occur. If high pressure injuries occur, the casualty should be sent immediately to a hospital. Do not wait for symptoms to develop.  
Obtain medical attention even in the absence of apparent wounds.
- Most important symptoms and effects, both acute and delayed : Local necrosis is evidenced by delayed onset of pain and tissue damage a few hours following injection.
- Notes to physician : High pressure injection injuries require prompt surgical intervention and possibly steroid therapy, to minimise tissue damage and loss of function.

tions should be taken to avoid breathing of material.
