SECTION 4) FIRST-AID MEASURES

Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing.

Immediately call a POISON CENTER or doctor.

If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by the POISON CENTER/doctor.

If breathing has stopped, trained personnel should begin rescue breathing or, if the heart has stopped, immediately start cardiopulmonary resuscitation (CPR) or automated external defibrillation (AED).

Eye Contact

Causes serious eye damage.

Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open.

Remove contact lenses, if present and easy to do.

Continue rinsing for a duration of 30 minutes or until medical aid is available.

Take care not to rinse contaminated water into the unaffected eye or onto the face.

Avoid direct contact. Wear chemical protective gloves, if necessary.

Skin Contact

Take off immediately all contaminated clothing, shoes and leather goods (e.g. watchbands, belts).

Rinse skin with lukewarm, gently flowing water/shower for a duration of 30 minutes or until medical aid is available.

Immediately call a POISON CENTER or doctor.

Wash contaminated clothing before re-use or discard.

Ingestion

If material has been swallowed and the exposed person is conscious, give small quantities of water to drink.

Never give anything by mouth to an unconscious person.

Rinse mouth.

Do NOT induce vomiting.

Immediately call a POISON CENTER or doctor. If vomiting occurs naturally, lie on your side, in the recovery position.

Indication of any immediate medical attention and special treatment needed

Treat symptomatically. Contact poison treatment specialist immediately if large quantities have been ingested or inhaled. No action shall be taken involving any personal risk or without suitable training. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Small Fire : Dry chemical, foam, carbon dioxide, water-spray or alcohol-resistant foam. Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces. Large Fire : Water spray, fog or alcohol-resistant foam.

Unsuitable Extinguishing Media

Do not use straight stream of water.

Specific Hazards in Case of Fire

In case of fire, hazardous decomposition products may include sulphur oxides. This material is harmful to aquatic life with long lasting effects. Fire-fighting Procedures

SECTION 6) ACCIDENTAL RELEASE MEASURES

Emergency Procedure

Isolate hazard area and keep unauthorized personnel away. Stay uphill and/or upstream. Ventilate closed spaces before entering. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing.

Recommended Equipment

Wear chemical protective clothing and positive pressure self-contained breathing apparatus (SCBA).

Personal Precautions

Avoid breathing vapor or mist. Do not get on skin, eyes or clothing.

Environmental Precautions

Prevent spilled material from entering sewers, storm drains, other unauthorized drainage systems and natural waterways by using sand, earth, or other appropriate barriers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

Methods and Materials for Containment and Cleaning up

Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Contaminated absorbent material may pose the same hazard as the spilled product. If spilled material is cleaned up using a regulated solvent, the resulting waste mixture may be regulated. Absorb Liquids in vermiculite, dry sand, earth, or similar inert material and deposit in sealed containers for disposal. Ventilate area after clean-up is complete.

SECTION 7) HANDLING AND STORAGE

General

Wash hands after use. Avoid breathing vapor or mist. Use good personal hygiene practices. Eating, drinking and smoking in work areas is prohibited. Remove contaminated clothing and protective equipment before entering eating areas. All containers must be properly labelled. Do not get in eyes, on skin, or on clothing. Eyewash stations and showers should be available in areas where this material is used and stored

Ventilation Requirements

Use only with adequate ventilation to control air contaminants to their exposure limits. The use of local ventilation is recommended to control emissions near the source. Report ventilation failures immediately.

Storage Room Requirements

Use non-sparking ventilation systems, approved explosion-proof equipment and intrinsically safe electrical systems in areas where this product is used and stored. Store in a cool, dry, well ventilated area, away from sources of ignition and incompatibilities. Keep containers securely sealed when not in use. Containers that have been opened must be carefully resealed to prevent leakage. Indoor storage should meet OSHA standards and appropriate fire codes. Empty containers retain residue and may be dangerous.

SECTION 8) EXPOSURE CONTROLS/PERSONAL PROTECTION

Eye protection
